First Aid administered by qualified pool or school first aider. Pool medical emergency procedure followed if injury is moderate or serious. Incident report to be completed before supervisor leaves the pool. |
| Person is lost or unaccompanied | Inadequate supervision Inadequate supervisor- student ratio Person's lack of awareness of risk in such a situation | Ensure students are made aware of the requirement to remain in view supervisor at all times. Ensure that supervisors personally conduct regular and careful headcounts. | All supervisors of visiting group Students | At discussion meeting with entire group before departure to the pool. Reminders given while at the pool. | Contact pool staff. Pool Staff to follow procedures to locate missing person. When located missing person will be returned to reception area to be collected. |
| Drowning | Inadequate supervision Person not aware of pool depth Person's lack of awareness of risk in such a situation Horse play Inadequate supervisor – student ratio | Ensure students are made aware of the requirement to remain in view supervisor at all times. Ensure that supervisors personally conduct regular and careful headcounts. Ensure students are aware of which pools can be used for swimming individual swim ability. Lifeguards to supervise all pools that are in use. Ensure supervisors are in correct ratio and are actively supervising. | All supervisors of visiting group Students Lifeguards | At discussion meeting with entire group before departure to the pool. Reminders given while at the pool. In case of emergency /accident. | Person rescued from pool. First Aid administered by qualified pool or school first aider. Pool 'medical emergency' procedure followed if injury is moderate or serious. Incident report to be completed before supervisor leaves the pool. |



| Weather related hazards | Lack of adequate protection against: dehydration - heat - cold rain - wind - UV radiation | • Visitors must check the weather forecast and ensure every student is suitably protected from the elements, particularly wind and sun protection when using outdoor pool and facilities. | All supervisors of visiting groups | At discussion meeting with entire group before departure to the pool. Reminders given while at the pool. | Supervisor notifies pool staff of person's condition. This action must be taken. First aid administered by qualified pool or school first aider. Pools 'Medical Emergency' procedure followed if injury is of concern. Incident report to be completed before supervisor leaves the pool. |

| Sick person | Lack of medication Pre-existing condition | Please ensure that all required medications (for asthma, allergies etc.) are readily at hand and that pre-existing conditions are notified, and that provision has been made for this. | All visiting supervisors | Discussed with supervisor prior to arrival at the pool. As and when necessary Upon the arrival of qualified first aid personnel | Supervisor notifies pool staff of person's condition. This action must be taken. | Special needs not catered for. | Individual needs of visitors (e.g., intellectual, mobility, medical, behavioural) are not acknowledged and/or lack of awareness of these needs. | Supervisors need to be informed of any students in their care that require and special requirements. | All supervisors of visiting groups. | Ensure supervisors have appropriate equipment and are trained to meet individual needs. | Not an emergency situation. |
| Burns | Accidental spillage of hot drinks Accidents around BBQ area | Students to be supervised by adults in the café area. Students to be supervised by adults in BBQ area. | All supervisors of visiting groups. | Supervising adults will be instructed by group leader of their responsibilities. | Supervisor notifies pool staff of person's condition. This action must be taken. First aid administered by qualified pool or school first aider. Pool 'Medical Emergency' procedure followed if injury is of concern. Incident report to be completed before supervisor leaves the pool. |



| Toilet accident | Excitement Waiting till last minute Not knowing toilet location Not taking toilet breaks when offered. Person with bladder problem | Supervisors to familiarise themselves with the location of toilet facilities around pool. Use toilets at the entrance of the pool in changing rooms upon arrival. Remind / point out toilet facilities during briefing. | All supervisors of visiting group Students | At discussion meeting with entire group before departure to the pool. Reminders given while at the pool. | Supervisors are responsible to be prepared for and take action if soiling event occurs. Pools staff will implement Faecal accident procedure if the incident is in the water. |

| Fire | Deliberate, accidental, careless activity | Care with use of tools and accelerants. Care with BBQ and gas bottles. As and when suspicious behaviour is reported. | Pool staff will implement 'Fire Emergency' procedure. All visitors will follow directions of pool staff. |
| Earthquake | Natural Process | Unpreventable | Swimmers will be moved out of the pool by staff member using 3 short sharp whistles | Heeding predictions | Pool staff with implement 'Earthquake' procedure. All visitors to follow directions of pool staff. |
