HOST SCHOOL – ATTACHED SCHOOL KEY INFORMATION

The purpose of Waikato Secondary Schools Sport Association [WSSSA] “Host School – Attached School” Agreement relationship between a “member” school and “other member” school is to cater for **School Sport NZ [SSNZ]** Clause.

1 Student Eligibility.

- The intent of **WSSSA** Host School - Attached School Agreement is to consider requests which involve a participating School with a roll of fewer than **100 students**. Principals should be aware these arrangements should not position the Host school into displacing one of their own students from play.
- This agreement would be a precursor to students from attached schools’ involvement at North Island and NZ Secondary School events – the latter for which there are additional applications required. This is the host school responsibility.
- For the **WSSSA**, alignment of students from an Attached school to a Host school is by agreement between Principals of the schools and there can be no variation to this agreement.
- Students wishing to play in **WSSSA** sanctioned activity **may only play** for their **nominated Host School** & not another school [apart from their own if numbers permit].
- Students from Attached Schools will be required to pay all fees and any other dues required by the Host School and abide by the sports policy & protocols of that school.
- Completed and signed **HOST SCHOOL – ATTACHED SCHOOL AGREEMENT** forms must be submitted on the approved form **APPENDIX III(B)** to **WSSSA** at least **two weeks prior** to the commencement of any composite teams participating in a **WSSSA** sanctioned event.
- The **WSSSA** would advise **SSNZ** in support of any applications made by Host Schools to **SSNZ** and National Sports Bodies for Island or National events.
- At an Island or National level, the ultimate sanction would, on the Host school’s application, come from the National Sports Organisation via a recommendation from **SSNZ**. Such requests need to be made to the **SSNZ** at least **2 months prior** to any **Island or National** event or qualifying event associated with these.

HOST SCHOOL - ATTACHED SCHOOL AGREEMENT FORM

The agreement is between _____ (Host School, School A) that wishes to provide sport opportunities for students from _____ (Attached School, School B).

In signing this agreement, both parties agree that:

- All other WSSSA Eligibility rules regarding age and attendance of the students are met.
- School A will be the Host (hereafter referred to as the 'Host School') for student[s] from School B (hereafter referred to as the 'Attached School').
- The student[s] from the Attached School will be part of the team[s] for the season and not selected only for certain fixtures - i.e. they are registered and participate as a regular member of the team: The codes we wish for consideration are _____.
- The Principal of the Host School agrees to take responsibility for the students of the Attached School.
- If the Host School wishes to include students from the Attached School at National or Island competitions in any code, an application must be made to Schools Sport NZ [via WSSSA Executive] 2 months prior to an event. The application(s) will be forwarded, with a recommendation from School Sport NZ to the relevant National Sporting Organisation that may or may not, at its sole discretion, approve the application.
